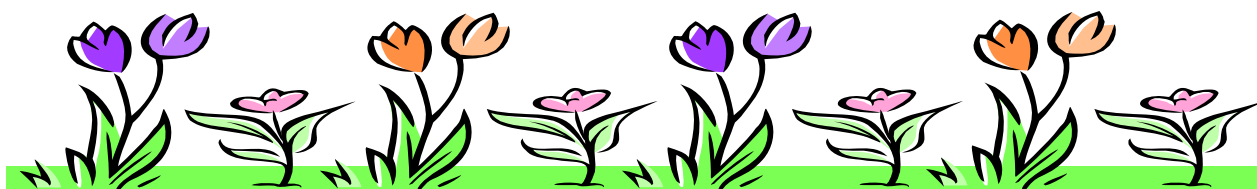
EVERCARE

Evercare is a specialized Medicare Advantage Insurance Plan that is designed specifically for residents in Long Term Care facilities. Wesley Homes Health Center has been successfully affiliated with the Evercare system for over two years. Evercare is designed around the services of a Nurse Practitioner who works in the facility in collaboration with a physician and facility staff. The program emphasizes ongoing communication with the enrollee and his/her family.

Because Evercare is a Medicare Advantage Plan, it requires formal enrollment, but this can be a very simple process. Though not everyone at WHHC will be eligible for this program, many will likely find it a good fit.
